1. Amend to change bid opening date to read from: 9:00 a.m. August 30, 2013 to now read: **9:00 a.m. September 06, 2013.**
2. On Page 1 "Special Reminder to Prospective Bidders" amend to delete the (x) on Brochures/Descriptive Literature in its entirety. No longer applicable.
3. On Page 8 amend to replace the Register of Wage Determinations under the Service Contract Act from June 13, 2012 to June 19, 2013. (See Attached updated Register).
4. On Page 3 under "Required Delivery Date" amend to read from: "Effectuated date for this contract is October 1, 2013. A Notice to Proceed (NTP) will be issued to the successful bidder. Commencement date will be in 30 days upon receipt of NTP (service may commence earlier). For a period of one (1) year with an option to renew on a year to year basis for two (2) additional years subject to availability of funds"; to now read: **"Effectuated date for this contract is October 1, 2013. A Notice to Proceed (NTP) will be issued to the successful bidder. Transition period to commence immediately upon receipt of NTP not to exceed September 30, 2013 Contract period is for a period of one (1) year with an option to renew on a year to year basis for two (2) additional years subject to availability of funds"**.
5. On Page 20 amend to change "Agency" to now read: "Bidder".
6. On Page 22 amend to change "Contractor to now read "Bidder".
7. On Page 68 amend to delete under "Other Accommodations" d.(2) in its entirety.

On Page 65 item #4.7 "Menu Preparation" amend to read: The initial menu, menu for the month of October 2013, shall be reviewed and approved by a Licensed Nutritionist (LN) or Licensed Dietitian (LD) and submitted with the Invitation for Bid package. Menus thereafter, shall be prepared by the Bidder and submitted to DPH&SS, DSC, at least thirty (30) working days prior to their implementation. It is **mandatory** for the October 2013 menu to be submitted with the bid package. Upon award of the bid, the Bidder shall ensure menus used in this program are reviewed and approved by a Licensed Dietitian.
